Treaties: WHO International Health Reg (2005)

- Attorney Todd Callender, Jan. 2022 podcast
- Two main reports: Legal Walls of the Covid-19 Kill Box (Feb. 2022) and American Domestic Bioterrorism Program (April 2022)
- Legal Walls - global framework, UN (1945), WHO (1946)
- ADBP - Timeline of US changes in law, from 1944 Public Health Service Act, through 1983 'public health emergencies' program, through Project Bioshield Act (2004), PREP Act (2005).
- Development of this parallel military-public health emergency law ongoing.

Core findings

- Public health emergencies are pretexts for power consolidation and legalized mass murder using State-sponsored biochemical warfare and weapons camouflaged as ‘vaccines,’ ‘countermeasures.’
- Orchestrated set of Constitutional crises, worldwide
- Global mechanisms: treaties and treaty-like international legal instruments.
- Domestic mechanisms: Statutes, regulations, executive orders, contracts, scientific R&D guidance, legal interpretation documents.
- Mirrored at all levels (federal, state/province, local/county)
- Mirrored in all countries and regional coordinating organizations (EU, OAS-PAHO)
- Covid-19 fullest demonstration/use of the system so far.

PROJECT BIOSHIELD ACT

(US Congress, 2004)

- Food Drug and Cosmetics Act, Section 564 (21 USC 360bbb)
- Governs regulation-exempt development, manufacturing, distribution and use of ‘countermeasures’ during declared emergencies.
- Legalizes public-private partnership to make and use biochem weapons.
- Core provision: 21 USC 360bbb-3(k): “If a product is the subject of an authorization under this section, the use of such product within the scope of the authorization shall not be considered to constitute a clinical investigation.”
- Public statements about testing, safety, efficacy, etc. = FALSE.

PREP ACT - Public Readiness & Emergency Preparedness (US Congress, 2005)

- Public Health Service Act, Section 319 (42 USC 247d)
- Governs consolidation of power, HHS Secretary, to declare, maintain and wield unchecked authority during ‘public health emergency.’ Purports: no judicial or Congressional review or oversight; no authority for states to reject or defy.
- Legalizes HHS Sec., w/ DoD, DOJ, DHS, NSC, operation of mass murder program, camouflaged as public health; license to kill delegated to state and local health, law enforcement (police), private contractors: w/ no criminal or civil liability.
- Core provision: 42 USC 247d-6d(c)(4): “*Defense for acts or omissions taken pursuant to Secretary’s declaration.* Notwithstanding any other provision of law, a program planner or qualified person shall not have engaged in “willful misconduct” as a matter of law where such [person] acted consistent with applicable directions, guidelines, or recommendations by the Secretary regarding the administration or use of a covered countermeasure.” Legalized “just following orders” defense Nuremberg.

Conclusion

- Observed, recorded global injuries and deaths of human beings are result of **INTENTIONAL ACTS OF WAR camouflaged as public health programs and medical countermeasures: 'vaccines' and many others.**
- Supported by evidence from funeral directors, embalmers (O'Looney); clinical trials (Jackson); regulatory/FDA lot and batch toxicity (Yeadon, Paardekooper, Latypova, Schmeling, McKernan); financial (Austin Fitts, Titus); VAERS; many other evidence collections and analysts.

Covert global civil war.

THREE priorities for killers:

- **PERCEIVED LEGITIMACY** - They want people to believe concentration of Monster power is lawful, morally sound, and materially/practically useful for dealing with threats/emergencies, and also believe that prior (nation-state) governments are illegitimate/inadequate/incompetent, thus power should transfer to UN/globalists.
- **SPEED** - They want to reduce world population, and especially North American and Western European population, to meet 2030 deadline.
- **PLAUSIBLE DENIABILITY** - They want people to believe that intentional, manufactured biochemical and financial attacks, gov. institutional failures are natural or accidental phenomena (disease, weather events, fires, spills, spontaneous wars)

Priorities in conflict. Gradual legal changes and gradual sterilization and induction of chronic disease 1940-2019 not on track to meet 2030 goals.

2020-2024 - Rapid, massive, coordinated concentration of power alerted some of the targets that something weird was happening.

Responses

- This makes sense of things that are not well-explained by regulatory capture, Big Pharma profiteering, or regulatory incompetence.
- What the hell? How can worldwide governments be injuring and killing their people intentionally and legally?
- Why? Financial/debt reduction (health care, pensions, longevity); AI/robotics (surplus population); desire to control/enslave.
- Who? Private owners of BIS and national central banks through control of money supply, currency, banking of countries.
- Emotionally processing it is more difficult than understanding the facts and mechanics. Takes time.

WHAT TO DO:

- **ENJOY** the God-given gift of your life as fully as you can. Love & spend time with your family and friends. Do good work. Pray.
- **DEFY** orders to hurt yourself or others; help others defy orders.
- **UNDERSTAND** and **SPEAK UP** about the lie-based, automatic, murder-legalizing transfers of power embedded in laws.
- **FILE cases** designed to draw these legal facts into the open, by forcing defendants to cite to them in their motions to dismiss and defense filings.
- **PUSH/SUPPORT lawmakers and courts** re-asserting nation-state Constitutional rule of law: to **REPEAL/NULLIFY/BLOCK** murder-authorizing statutes, regulations, programs. WeThePeople50.
- **PUSH lawmakers to WITHDRAW** countries from supranational treaties and conventions. #ExitWHO and IHR, UN, EU, BIS treaties.

Uses of Monster's desire for legitimacy

- Attack Monster credibility (imposters/occupiers), and legitimacy of Monster acts. Point out, discredit, and condemn killers.
- Treaties, conventions, statutes, regulations, executive orders to transfer power are **identifiable acts**; passed and/or signed at locations, on dates, by identifiable lawmakers and executives
- Current **federal lawmakers** hold the power and have **legal grounds to WITHDRAW** their countries from international treaties (i.e. #ExitWHO; Brexit from EU); **REPEAL** the implementing statutes and regulations (i.e. PREP Act; Project BioshieldAct/EUA, etc.)
- **State and county lawmakers** have the authority to **REPEAL** state- and county-level implementing laws and programs, and **BLOCK** federal and international laws and treaties.

Treaty withdrawal, repeal and criminal prosecutions at nation-state level (not ICC)

- Central bankers also seek to destroy public trust in nation-state governments, to create pretext for permanent transfer of all governing power to UN or successor totalitarian global government. (Trying to use ICC or European Court of Justice plays into their hands.)
- Related to sovereign immunity under domestic laws - exemption from criminal and civil liability for government officials, because sovereign not capable of forming malicious intent, only individuals. Once a person acts with malicious intent, he/she forfeits government official status and becomes imposter, outlaw.
- Vienna Convention on the Law of Treaties (1969, 1980 in force) - Part V - Invalidity, termination and suspension of the operation of treaties; **Article 62 - Fundamental change of circumstances**
- **Fundamental change of circumstance = public discovery that individuals pretending to represent legitimate sovereign rulers, have infiltrated national governments to enslave and kill citizens. They are imposters or occupiers to be expelled.**

Man and Society

- Relevance of Roman Catholic Church, pre-Vatican II.
- Pope Pius XII, On the Moral Limits of Medical Research and Treatment (1952, post-Nuremberg):

“Insofar as the moral justification of the experiments rests on the mandate of the public authority, and therefore on the subordination of the individual to the community, of the individual’s welfare to the common welfare, it is based on an erroneous explanation of this principle. It must be noted that, **in his personal being, man is not finally ordered to usefulness to society. On the contrary, the community exists for man.**”

- Totalitarianism - Perversion of “common good.”

The Global Public-Private Partnership (G3P)

Policy Makers

This is the part of the G3P where policy originates

BIS
Bank for International Settlements (BIS)
 The BIS ultimately controls the money supply & thus global markets, trade and national economies.

Central Banks
Central Banks (Coordinated by the BIS)
 The Central Banks are "going direct" and directly funding government spending. Monetary policy has effectively become fiscal policy.



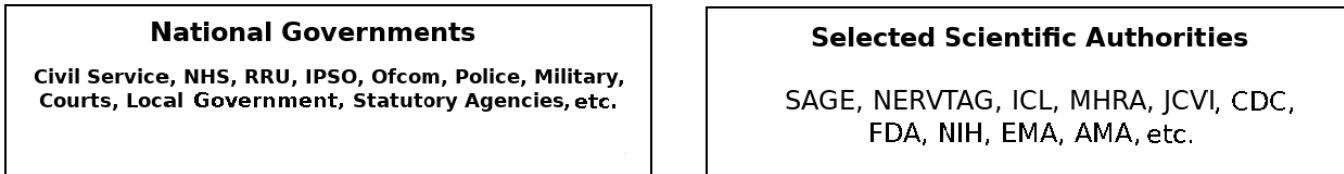
Think Tanks & Global Representative Groups
 The think tanks & globalist representative groups, such as the WEF, form the policy agendas. Working in partnership with the BIS and the central banks, they set the G3P objectives. These can then be pursued through partnership agreements with policy distributors and enforcers, such as the World Bank and national governments.

Policy Distributers



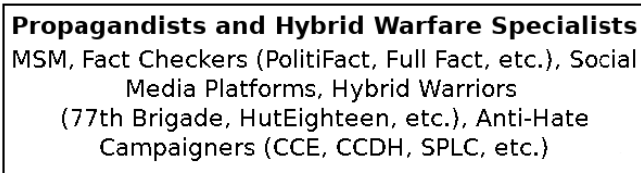
These organisations and bodies take policy directives from the policy makers and distribute them to the policy enforcers.

Policy Enforcers



The policy enforcers in national governments exploit or work with the selected scientific authorities to justify the policies they are required to enforce.

Policy Propagandists



The propagandists and hybrid warfare specialists are tasked with convincing the public to accept and hopefully believe in the policies. They use psychological manipulation, disinformation, misinformation, censorship and propaganda

Policy Subjects



We the people are the subjects of the policies that cascade down through the G3P system. These are funded via taxation and public borrowing, which benefit the BIS and the central banks and their corporate partners. The system is designed to exploit us, but we are an increasingly unnecessary component as the G3P seeks to transform the global economy based upon the financialisation of nature.
