1. The Office of Logistics has now completed its in-depth review of records, both current and in archives, in an effort to surface any information not heretofore reported on drug-related experiments.

2. Information in some files in archives belonging to the [REDACTED] of the Procurement Division revealed that [REDACTED], acting on behalf of the then Technical Services Division (TSD) of the Deputy Directorate of Plans (now Office of Technical Service, Deputy Directorate for Science & Technology, OTS/DDS&T), provided the funding mechanisms whereby grants were made to various institutions for the purpose of conducting drug-related research and experiments. Copies of the pertinent information found in these files are forwarded herewith. With the exception of a few names, presumed to have been excised when these documents were initially forwarded from the proprietaries, these papers are complete and therefore are considered sensitive. SUBJECT: Records About Drug Experimentation

3. The Chief of the [REDACTED] Staff during the period 1954 to 1966 was asked to review these files and advise if, to the best of his recollection, he knew of any other such Agency associations pertaining to drug-related matters or of any particularly sensitive activities heretofore not surfaced in pertinent investigations. He did not.

4. Because the [REDACTED] documents were uncovered during the course of a complete file-by-file review of the entirety of the OL archival records and because - based on those documents uncovered - OL has again reviewed all probable sources of drug-related documentation, it is believed that the probability of any drug-related documents remaining undiscovered in OL filing systems is so slight as not to merit further search.
